CHURCH OF CHRIST THE KING PASTORAL ADVISORY BOARD MINUTES OF MEETING OCTOBER 11, 2011

The meeting was opened with a prayer by Deacon Schofield. Members present were: Deacon Bill Schofield, James O'Leary, Roland Roy, Patricia Rose, Jeanne Carrier, Joseph Calise, Diana Calise, Donna Bosworth, and Walter Richardson.

Father Lemlin inquired if there were any questions or revisions regarding the minutes of the September 13, 2011 meeting. There being none, James O'Leary made a motion to approve the minutes which was seconded by Patricia Rose and unanimously approved.

Regarding the Capital Campaign, Father Lemlin advised the board that proposals from six companies had been reviewed. Assisting Father Lemlin with the review process were: Jeanne Carrier, Roland Roy, Michael Bosworth, and James O'Leary. On October 5th two companies were asked to make presentations. Debbie Decesaris also joined in listening to the presentations. After consideration of the presentations it was decided to invite the Cunneen Company to assist with the Capital Campaign. The invitation is subject to approval from Bishop Tobin. The cost for the Cunneen Company will be \$20,000.00. Ray Coogan from the Cunneen Company will be working with the committee and will assist in training. The fee also includes the costs of mailings.

Roland Roy noted that the cost of the other company would have been \$30,000 and that the company did not provide for much parish involvement. James O'Leary remarked that Ray Coogan did a great job with his presentation. Jeanne Carrier noted that she felt more comfortable with the presentation of Ray Coogan.

Father Lemlin noted that in 2006 plans had been made to create a 'candle room', but that the plans had never been completed. The plan now would be to install a floor and to replace the statues of Mary and Joseph with those of Anne and Jude. The church already has the material for the floor. Diana Calise inquired if the wall will have to be painted when the current statues are removed as there will not be replacement statues. Joseph Calise inquired about the income from candle donations. There was also a discussion about the wall in the 'candle room'. Father Lemlin reported that the Bazaar will take place on the weekend of November 19-20. Donna Bosworth noted that everything was running well and that some new people were assisting the Bazaar committee. Father Lemlin said that the church would be purchasing twelve new tables.

The topic of a volunteer appreciation dinner was discussed next by the board. Father Lemlin noted that the dinner would probably take place in June. There was a general discussion as to whether it was best to have one large dinner or smaller gathering for members of specific committees. It was decided to take up the question at the next meeting.

Under new business, James O'Leary inquired about lighting for the parking lot area. Father Lemlin remarked that the timers may need to be adjusted.

The next meeting date was set for November 29th at 6:30 p.m.

There being no further business, Roland Roy made a motion to adjourn which was seconded by Patricia Rose and unanimously approved.
